A	Each National Laboratory can only submit 1 application as the lead/prime per topic area. Staff from that Laboratory may team members on proposals being submitted by other National Laboratories
Q14	I have a couple of questions about the submission process for Labs applying to be part of the Sodium Ion consortium. Does each member of the proposed consortium need to submit a proposal into the Exchange system? For example: for a proposed consortium where ANL is the lead Lab and LBNL and PNNL are members, should there be only one submission, made by ANL, or does each Lab need to submit the particulars of their participation (including tasks, milestones, etc.) separately? My thought was that each Lab would have to submit separately, making note of partner Labs in the application, as this was the process for the cathode consortium submissions in the FY22 Lab Call DE-LC-000L096, under AOI 2. Also, because each Lab must submit its own AOP and the information from Exchange goes to populate the AOP.

Q15	It was still not clear to me if, when a Lab is a consortium member, not a Lead, they also need to submit their proposal in Exchange. In other words, is each member of the consortium responsible for submitting their proposal addressing "their corner" of the work of the consortium, or is everything included in the one proposal from the Lab who will be the Lead? When applying to the Sodium Ion consortium topic, should we submit a proposal into Exchange noting our proposed partners in the "Lab Partners" section, so that DOE, upon receiving the submissions from each Lab will be able to define the Lead Lab for the consortium based on the submission from each Lab that has applied?
A	For consortium projects, the partnering labs should identify a lead lab and only the lead lab will submit an application. All partner labs and responsibilities would be included in that one application.
