2	Eligibility	11/13/20	Is a DOE government-owned and government operated laboratory eligible under section 3.A.i of the subject FOA?	Yes. As stated in the modified Section 3.A of the FOA, "DOE/NNSA FFRDCs and DOE Government-Operated Government-Owned laboratories (GOGOs) are eligible to apply for funding as a subrecipient, but are not eligible to apply as a prime recipient."
3	Eligibility	11/16/20	Is there a limit on how many people per institution may apply to this funding opportunity?	As stated in Section 3.A of the FOA, eligible applicants are domestic entities, foreign entities, and incorporated consortia.  As stated in Section 3.F, "applicants may submit only one Letter of Intent, and may only submit a Full Application that corresponds to an eligible and compliant LOI. If an applicant submits more than one Letter of Intent, OTT will only consider the last timely submission for evaluation.... . This limitation does not prohibit an applicant from collaborating on other applications (e.g., as a potential Subrecipient or partner) so long

Organizations described in section 501(c)(4) of the Internal Revenue Code of 1986 that engaged in lobbying activities after December 31, 1995 are not eligible to apply for funding."

Innovation-accelerating, entrepreneurially-focused organizations (often referred to as accelerators or incubators) that support startups in AI and analytics technologies for the energy sector are eligible to apply to this FOA. How is this crucial aspect of EPIC addressed if there is no model required for ongoing funding?</p>	<p>As stated on pages 3 and 4 of the FOA, “it is DOE’s hope that this funding opportunity will enable successful applicants to enhance their organization’s resilience and operational sustainability.”</p> <p>Technical Review Criterion 1, “Technical Merit, Innovation, and Impact” includes a sub-bullet that addresses the “strength of the project plan to promote sustained movement of energy hardware technologies into the marketplace beyond the award period.” Applicants can reasonably infer that their ability to address this aspect of the merit review criteria would depend on their plan for and articulation of their own operational viability beyond the funding period.</p> <p>OTT offers no model or requirement in part because it does not want to constrain post-period of performance planning.</p>
20	Eligibility/non-profits	11/18/20 (Webinar)	<p>Regarding eligible applicants, will a successful applicant have to necessarily be an incubator/accelerator, or organization that exclusively focuses on energy innovation? What about 501(c)3 whose work is sometimes in those spaces?</p>	<p>As stated on page 1 of the FOA, “OTT welcomes as applicants ... organizations and multi-organizational applicants that self-identify as advocates for innovation and entrepreneurship.”</p> <p>While eligible applicants may include organizations that do not focus exclusively on energy innovation –such as 501(c) 3s whose work is sometimes in those spaces – OTT encourages prospective applicants to review the FOA, including the articulation of its goals, the attributes in the Applicant Characteristics and Elements of the Regional Engagement Strategy, and the Technical Review Criteria. High-scoring applicants will submit proposals that meet many, if not all, of the attributes described in the FOA.</p>

A Statement of Project Objectives (SOPO) is a narrative overview of the entire project that lists the Scope, Objectives, Tasks and Milestones of the project. The SOPO includes a narrative description of each Task whereas a WBS simply lists the Tasks and indicates their placement and duration over the project timeline.
